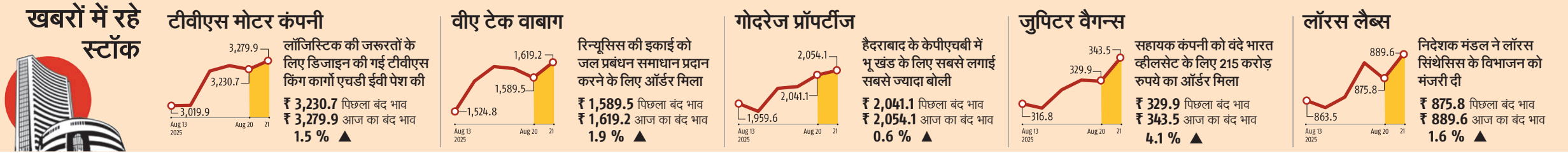

क्लीन साइंस एंड टेक्नॉलजी के ब्लॉक डील में ‘एक्जीक्यूशन एरर’

क्लीन साइंस एंड टेक्नॉलजी के शेयरों की ब्लॉक डील गुरुवार को तब गड़बड़ा गई जब एवेंडस स्पार्क इंस्टीट्यूशनल इक्विटीज ने प्रमोटरों की 24 प्रतिशत हिस्सेदारी बेचते समय 'एक्जीक्यूशन एरर' की बात कही। इस गड़बड़ी (जिसे आमतौर पर 'फैट-फिंगर' मिस्टेक कहा जाता है) के कारण निधारित 24 प्रतिशत से कहीं अधिक शेयरों के लिए बिक्री के ऑर्डर चले गए जिससे इस

शेयर के काउंटर पर उथल-पुथल मच गई। ट्रेडिंग वॉल्यूम बढ़कर 9.57 करोड़ शेयरों तक पहुंच गया जो 30-दिवसीय औसत 33 लाख से 29 गुना ज्यादा था। शेयर में 9 प्रतिशत तक की गिरावट आई और फिर नुकसान कम होकर 2.76 प्रतिशत की गिरावट रहा और शेयर 1,148.5 रुपये पर यह बंद हुआ। एवेंडस स्पार्क ने कहा कि ट्रुि्टि को एक्सचेंज के नियमन के अनुसार ठीक कर दिया गया है और विक्रेता पर इसका कोई प्रभाव नहीं पड़ा और न ही ट्रेड को कोई नुकसान हुआ।

भारत में कारोबारी गतिविधियां 2 दशकों में सबसे तेज : सर्वे

भारत के निजी क्षेत्र की गतिविधियों का अगस्त में रिकॉर्ड सबसे तेज गति से विस्तार हुआ। इस विस्तार ने कंपनियों को 12 वर्षों में सबसे तेज रफ्तार से कीमतें बढ़ाने का मौका दिया। सर्वे ने गुरुवार को बताया कि इस विस्तार को दबदबे वाले सेवा क्षेत्र की मांग से जबरदस्त समर्थन मिला। ये नवीनतम परिणाम एशिया की तीसरी सबसे बड़ी भारत की अर्थव्यवस्था में आर्थिक वृद्धि सुस्त होने के अनुमान के विपरीत हैं। वर्ष 2025 के पहले तीन महीनों में अर्थव्यवस्था अप्रत्याशित ढंग से 7.4 प्रतिशत की दर से बढ़ी। लिहाजा, इस वित्त वर्ष में अर्थव्यवस्था में 6.4 प्रतिशत की वृद्धि का अनुमान है। एसएंडपी ग्लोबल द्वारा संकलित एचएसबीसी का भारत का समग्र पचेजिंग मैनेजर्स इंडेक्स (पीएमआई) 61.1 से बढ़कर अगस्त में 65.2 हो गया। यह रायटर्स पोल के गिरावट के अनुमान 60.5 के विपरीत है।

वृद्धि और मुद्रास्फीति पर निर्भर करेंगे नीतिगत कदम

आरबीआई की मौद्रिक नीति समिति (एमपीसी) के सदस्य नागेश कुमार ने मनोजित साहा के साथ एक इमेल साक्षात्कार में कहा कि जहां मुद्रास्फीति में नरमी से नीतिगत गुंजाइश मिलती है, वहीं व्यापार नीति की अनिश्चितताओं पर भी नजर रखने की जरूरत होगी। उनसे बातचीत के अंश:

एमपीसी के ब्योरे में कहा गया है कि मुद्रास्फीति में नरमी के पहलू से नीतिगत गुंजाइश मिलेगी। आपको आगे और कितनी ढील की संभावना दिख रही है ? आर्थिक वृद्धि को रफ्तार देने के लिए फरवरी 2025 में एमपीसी की बैठक के बाद से रिपो दर तीन बार घटाई गई है और इस तरह कुल 100 आधार अंक की कमी की गई है। रिपो दर कटौती का असर उधारी और जमा दरों में देर से दिखा है। हालांकि, जून 2025 की नीतिगत समीक्षा में 50 आधार अंक की भारी कटौती से इसका असर तेजी से दिखा। अब तक, कुल मिलाकर, नए ऋणों और जमाओं के लिए उधारी दरों में 71 आधार अंक और जमा दरों में 87 आधार अंक की कमी आ चुकी है। इस देरी को देखते हुए आने वाले महीनों में उधारी दरों में और नरमी आ सकती है, खासकर यह देखते हुए कि तरलता अभी भी अधिशेष में है क्योंकि सीआरआर में कटौती का असर हुआ है। भविष्य के नीतिगत कदम वृद्धि और मुद्रास्फीति के बनते समीकरणों पर निर्भर करेंगे।

आपने एमपीसी ब्योरे में उल्लेख किया है कि व्यापार संबंधी अनिश्चितताओं से निजी निवेश पर प्रतिकूल प्रभाव पड़ा है। निजी निवेश को बढ़ावा देने के लिए भारत के नीतिगत उपाय क्या होने चाहिए ? अमेरिका द्वारा भारत पर 25 फीसदी टैरिफ और रूसी कच्चे तेल की खरीद पर बतौर दंड अतिरिक्त 25 फीसदी टैरिफ लगाने की घोषणा का असर हुआ है और व्यापार नीति संबंधी अनिश्चितताओं से

निजी निवेश धारणा पर प्रतिकूल प्रभाव पड़ा है। द्विपक्षीय व्यापार समझौते पर बातचीत जारी है। लेकिन अभी इश्यू में सफलता नहीं मिली है। यूक्रेन युद्ध को रोकने के लिए अमेरिकी राष्ट्रपति की कूटनीतिक पहल भी चल रही है। इन पहल का अमेरिका को भारत के निर्यात पर लागा होने वाले टैरिफ की दरों और रूसी कच्चे तेल की खरीद की वजह से भारत पर लगाए जाने वाले दंडात्मक टैरिफ पर भी असर पड़ सकता है। जाहिर है, निवेशक भारत के निर्यात पर लागा होने वाले अंतिम टैरिफ के बारे में अधिक स्पष्टता का इंतजार करना चाहेंगे।

अमेरिकी टैरिफ से घरेलू वृद्धि किस तरह से प्रभावित होगी ? भारत पर अमेरिकी टैरिफ बड़ी चिंता का विषय हैं। लेकिन चूंकि भारतीय अर्थव्यवस्था मुख्य रूप से घरेलू खपत और निवेश से ज्यादा संचालित होती है, निर्यात से कम, इसलिए मुख्य चिंता वृद्धि दर पर पड़ने वाले प्रभाव के बारे में उतनी नहीं है, जितनी कि संभावित रोजगार नुकसान और एमएसएमई पर पड़ने वाले असर के बारे में है। ऐसा इसलिए कि अमेरिका भारत के श्रम-प्रधान उत्पादों जैसे कपड़ा और परिधान, चमड़े के सामान, रत्न और आभूषण, झींगा तथा अन्य खाद्य उत्पादों के निर्यात के लिए एक प्रमुख बाजार है, जिन पर एमएसएमई का दबदबा है। उम्मीद है कि रूसी तेल खरीद पर दंडात्मक टैरिफ वापस ले लिया जाएगा और मौजूदा द्विपक्षीय व्यापार वातांण अंततः भारतीय निर्यात पर अमेरिकी शुल्क को कम करके अधिक सहज स्तर पर लाने में सफल होगा।
